NON-PAYMENT:

Can you be charged with Grand Theft if not returning rental equipment?

While this may seem like a complex legal issue, the answer is that yes, you can be charged with grand theft if you rent a vehicle (asset) and don't return it. In most cases, in order to be guilty of grand theft, a person has to take property from the owner without the owner's consent and with the intent to prevent that owner from having the property, either for a short period of time or indefinitely. Not returning a rental car wouldn't seem to fall under this umbrella but it does.

Think of it this way. If you rent a car and don't return it, you are essentially depriving the owner of the property – the car rental company – of their property. If the owner of the car calls the police and reports the car stolen, then you could be charged with auto theft.

If you don't make the weekly pre-payment, and vehicle is not immediately returned:

We cancel registration plates, and report vehicle stolen.

We hire a recovery agent to find and return equipment.

We file claim with your insurance for stolen vehicle / equipment.

A Lawyer / Collection agency recovers all expenses incurred from renter.
